- 2. This Notice shall inure to the benefit of, be binding upon and become a covenant that runs with the real property. Every person who now or hereafter owns or acquires any right, title or interest in or to any portions of the real property is and shall, by recordation of this Notice in the Office of the County Recorder, San Diego County, California, be conclusively deemed to have notice of the stated water pressure condition, whether or not any reference to this Notice is contained in the instrument by which such person acquires an interest in the real property.
- 3. Declarant hereby subjects the real property (and all portions thereof) to this notice and declares that it is its specific intent that this Notice set forth herein shall be deemed a covenant running with the land and shall pass to and be binding upon the Declarant's successors entitled to the real property (or any portions thereof).
- 4. Each and every contract, deed or other instrument hereafter executed covering or conveying the real property (or any portion thereof) shall conclusively be deemed to have been executed, delivered and accepted subject to this Notice by recordation of this Notice in the Office of the County Recorder, San Diego County, California. The Declarant hereby declares its understanding and intent that the circumstances concerning the water pressure condition, as cited in the Declaration and as set forth herein, touch and concern the land in that the Declarant's legal interest in the real property has been considered by Declarant in Declarant's determination of the value of the real property and Declarant's establishing the value of the dwelling unit thereon at the time said real property was (or will be) offered for sale to the general public by Declarant. The Declarant hereby further declares its understanding and intent that the benefit of this Notice touch and concern the land by enhancing and increasing the value and use of the real property by the Declarant.
- 5. The terms of this Notice may be enforced by the District or its successors or assigns. In the event of any controversy, claim or dispute relating to this Notice or the breach thereof, which the District is or shall attempt to enforce, the District shall be entitled to recover from said party reasonable expenses, attorney's fees and costs, if the District prevails in such controversy.
