## MITIGATING INCREASING WATER COSTS

Raising costs to impact everyone, and here in San Diego County, with inflation costs up over 6 percent, we see increases higher than the rest of the nation.

A 2017 American Water Works Association's report and a study this year by statista.com documented that San Diego's water rates were among the highest in the nation. San Diego households spend more than twice the national average on water and will continue to rise with the San Diego Water Authority's (SDCWA) anticipated rate increases of at least 5.5 percent in 2023.

For decades, our ratepayers have been burdened by rapidly rising water costs. Just over the past decade, water costs have shot up an average of 8 percent per year. Over the last 25 years, SDCWA has made significant investments to construct new storage and treatment facilities that provide limited benefit to the more rural agricultural communities served by RMWD. As a result of these investments, the standard treated water rate from SDCWA is over \$600 more expensive than the Eastern Municipal Water District (EMWD) located in Riverside County.

With over 60% of the District's water being purchased by agricultural users, the increasing costs for water have negatively impacted this area in particular. The District's pursuit in detaching from SDCWA and annexing into EMWD is intended not just to save money for our ratepayers but is necessary to help preserve the foundation of the local economy and the appeal of our local communities.

We encourage our ratepayers to stay involved and engaged in this process as the Local Agency Formation Commission (LAFCO), which is responsible for overseeing the establishment, expansion, and boundary changes of cities and special districts, including water districts, moves forward in their analysis on the proposed detachment application submitted by Fallbrook Public Utility District (FPUD) and RMWD.
