(Basic rate for all water delivered through the water meter)

C. WATER ALLOCATION PENALTY RATES

Certified agricultural users (MWD's Interim Agricultural Water Program "IAWP" participants) who are subject to the MWD reduction (currently 30%) and who exceed their monthly usage allocation will be charged a penalty of \$2.95 per unit¹ for each unit exceeding that allocation.

A penalty of \$3.44 per unit will be charged to SAWR customers who use greater than 100% but less than 115% of their allocation, for each unit exceeding that allocation. A penalty of \$6.17 per unit will be charged to SAWR customers who use 115% or more of their allocation for each unit exceeding that allocation. Customers using 6 units or less per month will be exempt from the allocation penalty.

A penalty of \$3.55 per unit will be charged to domestic customers who use greater than 100% but less than 115% of their allocation, for each unit exceeding that allocation. A penalty of \$6.27 per unit will be charged to domestic customers who use 115% or more of their allocation for each unit exceeding that allocation. Customers using 6 units or less per month will be exempt from the allocation penalty.

The Water Allocation Penalty charges shall apply only in the event that mandatory water conservation is in effect.

FIXED ACCOUNT CHARGES

A. METER SERVICES CHARGES

(Charge assessed on each active water meter to generally pay 50% of the District's fixed operating and administrative costs.)

AUTOMATIC ADJUSTMENTS THAT PASS THROUGH WHOLESALE CHARGES FOR WATER

The RMWD fees or charges established herein shall be automatically adjusted to pass through adopted increases or decreases in wholesale charges for water. The term wholesale charges: shall include SDCWA and SDCWA allocated Metropolitan Water District charges. Notice of any adjustment pursuant to this schedule shall be given to RMWD customers not less than 30 days before the effective date of the adjustment. This section only, regarding automatic adjustments, shall expire on August 31, 2014.
