## **CELEBRATING 25 YEARS OF WATER AWARENESS CALENDARS**


Each May, North County Water Agencies (NCWA) recognizes "National Drinking Water Awareness Month" by partnering in a Drinking Water Awareness Poster Contest for elementary age students. ## **NEW BACKFLOW TESTER CONTRACTOR**

Starting in January 2017, Rainbow Municipal Water District (RMWD) entered into a Professional Services Agreement with Temecula Valley Backflow (TVB) who will now be testing and repairing all customer-owned backflows who have opted into the District's Backflow Testing and Repair Program. More information will be coming on the subject in future newsletters.

The District's Backflow Testing and Repair Program was established to track the installation and testing of service protection backflow assemblies within the District's service area. It is designed to ensure high quality and reliable potable water services for all of our customers required to have backflow device. The cost associated with the program are included in monthly bills for customers with approved assemblies. By purchasing the testing service for thousands of devices in one contract, we pass on the savings to our customers. The program is voluntary, so if you want to test your device on your own please let us know.

Below are some frequently asked questions (FAQs):

## WHY DO I NEED A BACKFLOW PREVENTION DEVICE?

After water passes through a water meter into a home or business, it must be prevented from flowing back into the main water supply. Backflow prevention devices are designed to maintain water quality by preventing this reversal of flow and keeping any potential pollutants or contaminates from entering the water supply. These devices play an essential role in protecting the integrity of our water systems and helping to keep our drinking water clean and safe.

## WHY DO I NEED MY DEVICE TESTED?

Backflow prevention devices must be tested annually to ensure they are functioning properly. RMWD has the task of determining where these devices are needed and maintaining records on each device to ensure the safety of our water systems.
