LAFCO Votes to Approve Detachment with Exit Fee

The San Diego Local Agency Formation Commission (LAFCO) met for a public hearing on July 10, to approve detachment of Rainbow Municipal Water District (RMWD) and Fallbrook Public Utility District (FPUD) from the San Diego Water Authority (SDCWA) to the Eastern Municipal Water District (EMWD) in Riverside County.

LAFCO was presented with several exit fee options, ranging from no fee to \$125 million for 10 years. The Commission voted 5-3 in favor of detachment, with an exit fee of \$62.9 million paid over five years and credit of \$38.6 million. The total exit fee equals to \$24.3 million or \$4.9 million annually.

What are the Next Steps?

A vote will be scheduled in the future for RMWD and FPUD ratepayers. More information on the detachment will be made available and shared as details unfold. Thank you to our community members for sharing their stories and opinions on the detachment.

Know Before You Dig

Summer is here and home improvement projects are underway for many property owners. Before starting those projects, remember the underground utility lines below the surface of our roadways, along sidewalks, and private property that may be damaged or cause injury during a dig.

If you are excavating even for the smallest of areas, follow these steps:



Mark your area to dig with a small flag or outline with paint.



Contact **811** or visit **digalert.org** to request a Dig Alert two business days before a project start.



Wait for a site visit from Dig Alert before putting a shovel in the ground.

Water Efficiency is the Wave of the Future

The rain finally arrived this year, and water conservation efforts shifted. What does this mean for us, and how do we move forward with water use? Water conservation efforts are less urgent than last year, but efficient water use is always the path to prepare us for future periods of limited water supply. Even minor adjustments help sustain water in our community when agriculture and residential ratepayers use water efficiently.



 Install Flume, a smart water monitoring system that sends electronic notifications to track usage, detect leaks, and reduce water waste. The District offers a discounted rate to purchase the Flume device with self-installation in less than 10 minutes.

 Evaluate landscaping and identify areas for reducing or minimizing water usage. The County of San Diego Waterscape Rebate Program offers a variety of options to reduce water use by installing drip irrigation systems, upgrading plantings to native and low-water plants, and installing rain barrels to capture rain.

 Consider whether changing out one agricultural crop for another is right for you. The CropSWAP is a crop conversion program designed to replace high-water-use groves with a water-saving crop or more efficient avocado rootstock reduce

costs and water usage for farmers. The grant-funded program has been successful for Rancho Water, and we are seeking interest from our ratepayers for future participation in a regional expansion of their program.
