On motion of Commissioner Horn, seconded by Commissioner Jacob, the following resolution is adopted:

WHEREAS, a resolution of application was submitted to this Commission for reorganization of territory to the Fallbrook Public Utility District, dissolution of Rainbow Municipal Water District, annexation of territory in Rainbow Municipal Water District to Fallbrook Public Utility District and expansion of Fallbrook Public Utility District’s latent powers to include territory formerly in Rainbow Municipal Water District, which resolution was adopted by the Board of Directors of the Fallbrook Utility District as Resolution No. 4815, dated April 28, 2014, pursuant to Title 5, Division 3, commencing with Section 56000 of the Government Code; and

WHEREAS, the Commission disapproved the proposed reorganization at its September 14, 2015 meeting, said reorganization involved: (1) Dissolution of the Rainbow Municipal Water District; (2) Annexation of the Rainbow Municipal Water District territory to Fallbrook Public Utility District; and (3) Expansion of Fallbrook Public Utility District's Sewer Latent Powers; and

WHEREAS, the territory proposed for reorganization is as described in the application on file with the Local Agency Formation Commission; and

WHEREAS, the Executive Officer of the Commission has filed his report on said reorganization, which report was received and considered by the Commission; and

WHEREAS, pursuant to Government Code Sections 56427 and 56425, the Executive Officer of this Commission set a public hearing on the proposed reorganization, dissolution, sphere of influence and municipal service review, and expansion of latent powers sewer service for July 6, 2015 which was continued to September 14, 2015, and gave notice of the date, time, and place of said hearing in accordance with Government Code Section 56666.

NOW THEREFORE, pursuant to the Cortese/Knox/Hertzberg Local Government Reorganization Act of 2000 (Government Code Section 56000, et seq.) the Local Agency Formation Commission of the County of San Diego does hereby disapprove the "Fallbrook Public Utility District and Rainbow Municipal Water District Reorganization" (Fallbrook Public Utility District and Rainbow Municipal Water District) proposal the Commission took the following action:

With Commissioner Abed, Alternate Commissioner Sprague and Commissioner Vanderlaan in opposition, on motion of Commissioner Horn, seconded by Commissioner Jacob, and carried by the remaining commissioners present, the Commission took the following action to disapprove the dissolution for the proposal "Rainbow Municipal Water District and Fallbrook Public Utility District Reorganization".
