## Construction Water Meter Application

1. A \$1,825.00 deposit is required at the time of application. The deposit, less the final bill, is refundable when the meter is removed. There is a \$115.00 non-refundable installation fee. Amount due is \$1,940.00. Construction meter will be installed within two business days of the date of deposit.
2. Billing is monthly and includes an operation & maintenance fixed fee of \$350.91 for a 3-inch meter, plus the charge for the water used during the billing period. Fees are subject to change. The current water fee is \$5.20 per unit (1 unit equals 748 gallons).
3. Relocation of a Construction Meter is to be done by District employees only. **There is a two-business day notice and a \$50.00 fee for this service.**
4. Water may be utilized from either a drop tank, water truck or fire hose. If a Fire Hose is used, the applicant must protect the hose from sudden pressure surges that may cause damage to the District's water lines.
5. Construction Meters are available for a **maximum period of 6 months**. Extensions may be available upon approval.
6. The applicant agrees that the water service is to be solely for construction purposes and shall comply with the Rules and Regulations of the District. The undersigned is responsible and agrees to pay for all charges and for any damage or loss of the meter or fire hydrant. Monthly field assessment of "Actual Use" will occur. If misuse is found, service will be terminated, the meter will be immediately pulled, and a penalty fee assessed.

**The undersigned applicant is aware of Penal Code Section 499 that states:**

**EVERY PERSON WHO, WITH INTENT TO DEFRAUD ANOTHER, CONNECTS WITH ANY PIPE OR MAIN CONDUIT OR FLUME USED IN CONDUCTING WATER, FOR THE PURPOSE OF TAKING WATER THERE FROM WITHOUT THE KNOWLEDGE OF THE OWNER, AND WITH THE INTENT TO EVADE PAYMENT THEREFORE, IS GUILTY OF A MISDEMEANOR.**
